- The location of the burning must be a least 500 feet from the nearest occupied dwelling other than a dwelling located on the property on which the burning is conducted.

- The burning must be controlled to avoid creating a traffic hazard on any public road, street or highway as a result of the contaminants emitted.
- Only wood and plant growth materials may be burned. Under no circumstances shall heavy oils, asphaltic materials, items containing natural or synthetic rubber, plastics or refuse be burned.
- Initial burning may be commenced only between the hours of 8:00 a.m. and 7:00 p.m. No combustible material is to be added to the fire between 7:00 p.m. and 8:00 a.m. the following day.
- Burning shall be conducted only when there is good ventilation and when the prevailing wind direction is away from any built-up area in the vicinity. No burning shall be conducted in areas under a current air stagnation advisory issued by the National Weather Service or during a draught emergency declared by the governor.
- Any fire shall be attended at all times.
- Failure to comply with this section shall result in a fine of not less than \$50.00 nor more than \$500.00. Each burning violation conducted on the same property shall be considered as separate violations of this chapter.
- Upon completion of the job or construction project, remove any debris, concrete, lumber, roofing material or other waste material resulting from such activity to a lawful disposal area.
- Provide on-site receptacles for litter as defined hereinabove and ensure that litter is properly placed in such containers to prevent scattering of such litter by wind or rain if such litter is not otherwise properly disposed of on a daily basis.
